On December 1, 2025, the Select Board posted an executive session and an open meeting, copies of the agenda are attached. The executive session agenda included one item pertaining to the town administrator: Vote to go into Executive Session per M.G.L. c. 30A, § 21(a)(2): To conduct strategy sessions in preparation for negotiations with nonunion personnel or to conduct collective bargaining sessions or contract negotiations with nonunion personnel. The open session agenda contained no mention of any Board action regarding the Town Administrator.

In the executive session, Chair Mark Bail stated his desire and intention to terminate TA Tammy Martin. John Clifford, representing Tammy Martin, informed the Board that doing so was a violation of her employment agreement and the Open Meeting Law as there was no mention of any employment action, including termination, included in the open session or executive session agenda.

Following a discussion without Ms. Martin or her attorney present, the Board Re-convened in open session, and, without explanation or justification, terminated Ms. Martin's employment. The Board also violated the OML by direct communication outside of the meeting between members Bail and Labonte, unlawfully conspiring to terminate Ms. Martin. When the Board went into executive session the Chair also declared that they would return to open session only to adjourn, which was false, as they returned to open session and terminated the TA. 
